Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.</p> <p>The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. MONOISOBUTANOLAMINE	TRIS AMINO and its surrogate chemicals have very little, if any, toxicity. They are mildly irritating to eyes at moderate concentrations, and do not cause allergic skin reactions. Ingestion of relatively high dosages can cause liver changes. Patients with decreased liver function should not be given these substances over extended treatment periods. They have been known to have a harmful effect on the foetus if taken during pregnancy.
